McLaren Capital Limited is an independent financial advisory company. This privacy policy explains how we use any personal information we collect about you when you use our services.

## INFORMATION COLLECTED

We collect information about you once you talk to us about your personal and financial circumstances. We may also collect information about you if you voluntarily complete customer surveys or provide feedback, for example. If and when we use our website to collect information about you the information may be collected using cookies.

## **USE OF INFORMATION**

We collect information about you to provide you with advice, periodically process your orders, manage your account and, if you agree, to contact you about products and services we think may be of interest to you. You can ask us to delete information we hold about you at any time, which we will do unless we have legal reason not to.

If you have consented to receive marketing, you may opt out at a later date. You have a right at any time to stop us from contacting you for marketing purposes.
